

i Kappa Alpha proves to be wrapping up another very successful academic year. With the Student Leaders' Banquet set to take place in the upcoming weeks, Alpha Kappa is nominated for a handful of organizational and individual awards including but not limited to "The Community Service Award," "The Most Remarkable Student Group," as well as the "Keystone Award." We are also putting the finishing touches on the International Fraternity's Award Application, which will hopefully lead to the Chapter's sixth consecutive Smythe Award, which is given to the top 5% of all Pi Kappa Alpha Chapters.

Alpha Kappa has continued to dominate recruitment at Missouri S&T. Danny Ryan (AK `06) and Steve Grelle (AK `06) did an exceptional job in the signing of 26 men for the fall semester. Under the leadership of Lucas Rottler (AK `05), those men have proven to be great additions to the Chapter. Also, Brother Grelle and Kaleb Hoffman (AK `08) recruited the largest class on campus for this spring with 12 new members. The Alpha Kappa rush strategies have continually proven to succeed in recruiting "the most best men!"

The men started the school year off strong in special events with a first place overall finish in both Greek Week and Homecoming. This is the first time in recent years that Alpha Kappa has been able to win both of these events in the fall semester. It was an all house effort to ensure that these events were successful; however, special thanks deserve to be given out to Brother Josh Kaltenbronn (AK `07) for all his assistance with both Greek Week and Homecoming. While he was not the Special Events Chairman, he was a pivotal part in the organization and execution process of many of the events in the competitions. Alpha Kappa also won the Homecoming King and Queen competition for the fifth consecutive year. This year's winners were seniors Lance Weinmann (AK `06) and Diana Meyers. Staying on the topic

Pikes have finished first in all of the major sports so far with several other high finishes in various sports. With this, the men have accumulated an 85-point lead over the second place competitor with only track and soccer left to compete in. PiKA's "B-Team", Hooligans, is also currently ranked 5th on campus with a 285 point cushion.

en years is supposed to be a long time — no it's not. Ten years ago we were struggling to understand what happened and how, or if we could, move forward. Over the years I have heard men tell me, "in some respects the fire was the best thing that could have happened to AK," they are wrong. But, I understand the sentiment underlying the statement that the "re-birth" of AK has resulted in a number of positive outcomes for our Fraternity.

There is no doubt that AK is a better organization than it was in the 1990's. Back then we had developed some bad habits within the active chapter, the House Corporation was distant and adversarial, and alumni were nearly non-existent in terms of involvement. It's not that we (all of us) didn't care, we had just grown apart and complacent. After the tragedy, we all discovered just how much we cared for AK. We put our hands and our strong backs together and we lifted AK up. We continue to lift up and support, allowing AK to achieve. The success of AK rests upon your shoulders.

We lost two good men ten years ago. One of them that terrible night, and one a few months later.

Jared Newman Adams, "Newman," died of smoke inhalation that night in his room. Newman was a 21-year-old double major in Physics and Electrical Engineering. He was an active and engaged Brother of AK and was the treasurer of IFC. We remember him for many things, especially his quick wit and that quirky little smile he had. He was simply a terrific young man.

We lost Bob Wolf the following August. I am convinced that the stress, the sense of loss and grief, a misplaced sense of responsibility (it was my responsibility, not his) combined to deteriorate his health to the point that we lost him. What could I possibly say about Bob Wolf that would adequately describe him and his contribution to all of our lives? He was an icon, a light that we all looked to for guidance and assistance in need. He gave himself to us, dedicated to our development and well being. Day in and day out, for nearly 50 years he poured his life into the men of AK, making our lives the better for it. AK would not be successful today, and likely would not exist today if not for this humble and dedicated man.

"Yesterday is gone forever, tomorrow is yet to be, the destiny of PiKA rests today with thee." We knew then, and we know now, that we must move forward. We must be dedicated to AK. We must achieve unreasonable success because of Wolf, Newman, and all those dedicated and humble men who have gone before. We can never take our eyes off of the light of truth, and love, and brothership. We must dedicate ourselves to the men who will be brothers at AK ten years from now,

or ten years after we are dead and in our graves.

No, the fire was not the best thing that happened to AK, it was the single most devastating thing that has happened in our history.

The best thing that happened to AK was that its Brothers, young and old alike, lifted AK to their shoulders and carried



AK over these last ten years, and continue to carry it into the future.

There were more than 90 people in attendance for the Dad's Day, which consisted of a brunch and awards banquet, along with softball afterwards. At the brunch, delicious food was served and Brothers of the fraternity received





various scholarships for their merits based on GPA, house offices, and campus leadership. The members of the Fraternity received in excess of \$42,000 from scholarships endowed by our alumni. After a few hours of socializing, house tours, and food digestion, a large group of Brothers and their families went to Kimmel Field. At Kimmel Field, everyone enjoyed themselves playing softball for a few hours as well as bonding closer to each other and their families.

Homecoming Royalty

For the fifth year in a row Pi Kappa Alpha has sat on top of the campus' Homecoming Court. Lance Weinmann (AK `06) and Diana Meyers (Student Council Vice President), both Pi Kappa Alpha candidates, were crowned Homecoming King and Queen during the ceremony.

Alpha Kappa also took first place in the overall Homecoming competition.



S&T Homecoming 2008

After coming off a first place finish in Greek Week 2008, Alpha Kappa was fired up about taking on their next special event, Homecoming. Alpha Kappa's own Curtis McDonald (AK `07) organized the Missouri S&T Homecoming this year for the Student Union Board, which proved to be beneficial in communications for the Chapter.

Special Events chair Lance Weinmann (AK `06) and his "right-hand-man," Homecoming Chair Josh Kaltenbronn (AK `07) assigned tasks to various pledge classes, and by doing that, seemed to orchestrate great results. The theme for Homecoming 2008 was "Arabian Nights," so the men decided to play on the movie Aladdin in their thought process towards the different events. Their banner pictured Joe Miner as Aladdin riding a magic carpet through the Arabian night sky. Pikes placed second in this first major event and that seemed to set the tone for the rest of the week's activities. During the week, AK competed in such events as movie skit reenactment (1st place), Joe Miner look-a-like (2nd place), as well as a handful of other smaller events. The competition ended on Friday when Pikes took second in the yard display competition, the last major event. The yard display was mainly comprised of a 12-foot tall, by 20-foot, long magic lamp, complete with smoke that came out the nozzle when rubbed. Along with the lamp, the men performed a skit where they recreated the scene where Aladdin first discovers the lamp and the genie. During the Miner football game, the Homecoming Court was announced, along with the champion of the Homecoming competition. Missouri S&T proudly crowned Brother Lance Weinmann (AK `06) and Diana Meyers Homecoming King & Queen, both representatives of the Chapter. Alpha Kappa is very proud to bring home a first place finish in Homecoming and cannot wait to bring it home again next year!

Community Service

Linking Hearts

On September 20, 2008, the members of Alpha Kappa participated in the Linking Hearts Carnival. This is an annual event for local kids to come and enjoy various carnival games, prizes, and food. Pikes set up a booth for kids to "Pie A Pike," face paint, and served cotton candy and snow cones. In addition to helping set-up and run their booth at the carnival, Pikes also volunteered as "Buddies" for the kids, where you spent the day with one or two kids taking them from booth to booth. Eighteen actives and 21 pledges participated in this event.



Tour of Missouri

On September 11, 2008, the members of Alpha Kappa volunteered as security personal for the Tour of Missouri, a bike race conducted as a memorial of the 09/11 tragedy. The race was split into 5 stages across the state, with the

4th running through downtown Rolla. Being the only Greek house to participate in the event, the event coordinator allowed Pikes to have all of 12th Street to run security and cheer on the racers. Nineteen actives and 14 pledges participated.

Habitat for Humanity

During the weekend of October 3rd, the members of Pi Kappa Alpha performed a weekend of community service with Habitat for Humanity located in Nashville, Tennessee



This service trip was one of the largest projects Alpha Kappa has participated in many semesters. Sixty-eight members volunteered all weekend, implementing such projects as interior painting, cutting and hanging siding, installing plumbing and storage accessories, securing drywall, packing insulation, and much more. They exemplified hard work, placing the Habitat management group two days ahead of schedule before the end of the weekend. While at Nashville, the St. Edward Catholic Church and School provided lodging, YMCA offered showering facilities, and Panera Bread Co. sponsored meals for the entire weekend. Enterprise Rent-A-Car provided the members with a fleet of rental vans to help make the 6 hour drive to Nashville. This service trip put Pi Kappa Alpha at more than 5,300 community service hours for the Fall 2008 semester.

Diabetes Walk

On September 28, 2008, 15 pledges traveled to St. Louis, Missouri to participate in a charity walk for diabetes. The Fall 2008 Pledge Class came up with the idea to help out one of their pledge brothers who has diabetes. They exemplified the qualities of a True Pike by planning and executing a community service event on their own, for one of their pledge brothers.



Pikes Win Again

The Chapter started with the goal of winning all three special events for the year and the drive to complete that goal showed as the men took on Greek Week as the first special event for the year. Overall, the week was a great success for the Chapter from beginning-to-end. They competed in several different events including opening and closing games, banner and float competitions, a carnival booth, blood drive, as well as many other smaller events through the week. AK had a great start to the week by winning opening games and then helped its cause by placing first in all three days of Idi-Odysseys, which are a combination of multiple small competitive events. The Chapter's 1st place float, a 10-foot tall "khaki factory," with smoke stacks, turn dials, music, and an internal skit, also helped secure the victory. Going along with the float theme, the banner (2nd Place) was done as a tribute to "Charlie and the Chocolate Factory." Now, for back-to-back years (three out of the last four), Alpha Kappa has brought home the Greek Week championship trophy.

After hosting a successful Greek Week `07, he was elected the President of IFC, a position not held by a Pike in over a decade. Earning the position of Zeus 2008 put him as the 3rd consecutive Pike Zeus, which has never happened in the history of AK. Brother Arnold after being selected Zeus at GODZ elections commented, "Here's to Zeus `06, `07, `08, and more to come!"









He also holds master's and Ph.D. degrees in metallurgical engineering and an MBA from the University of Michigan-Ann Arbor. He holds two U.S. patents for his work on cylinder block casting and manufacturing. Prior to working at Chrysler, Brother Winter was employed by Ford Motor Co. for 22 years. He and his wife Brenda live in Northville, Michigan, and have three boys.

Terry King

It is with much sadness that we announce the untimely passing of Brother Terry King; he was killed in an automobile crash on January 12, 2009. "Kinger" was initiated into AK chapter on Feb. 27, 1976. Not a UMR grad, however, he received his degree from Washington University in St. Louis. Brother King was an electronic components engineer and since 1991 was a contract employee with NASA. He worked at the Goddard Space Flight Center on numerous civilian satellite programs, most recently the James



Web Space Telescope. An outstanding engineer, he recently received an excellence award for his part in an investigation into instrument failures on the Space Shuttle. Brother King was a dedicated alumnus and a frequent contributor to the AK chapter. He most recently visited for the 100th Anniversary and the addition dedication. He lived in Columbia, Maryland.

Donald W. Peterson

Brother Donald W. Peterson (AK `50) was partner in the intellectual property law firm of Leydig, Voit and Mayer. He served as deputy assistant secretary of commerce and deputy commissioner of patents and trademarks during the last two years of the Reagan Administration. Prior to his appointment as deputy commissioner, Brother Peterson had been with the Monsanto Company since 1953. He joined Monsanto as a chemical engineer and, while



attending night law school, he transferred to the patent department. He served in various capacities including senior attorney — licensing; trademark counsel; patent counsel — polymers and petrochemicals; patent counsel — commercial products; patent counsel — agricultural products; and was named associate general patent counsel in 1981. He elected early retirement in December of 1985.

Brother Peterson was a member of the American Bar Association, the American Intellectual Property Law Association, the Licensing Executives Society, the Patent and Trademark Office Society, and the Bar Association of Metropolitan St. Louis. He was a vice president and member of the Board of the Inventors Association of St. Louis. He was a past chairman of the Patent Law Committee of the National Agricultural Chemical Association (NACA) and the Patent law Committee of the International Association of Agrochemical Manufacturers. Brother Peterson was also a founding member of the International Anticounterfeiting Coalition and a vice president until he accepted the presidential appointment.

Brother Peterson received a B.S. degree in chemical engineering from Missouri S&T in 1950, his J. D. degree from the St. Louis University Law School in 1957, and an honorary doctorate degree from Missouri S&T in 1989. He was a member of the bar of the State of Missouri, the District of Columbia and the U.S. Supreme Court. He retired as municipal judge of Des Peres, Mo., in 1985 after having served for 25 years in that elected office. Brother Peterson was a devoted husband of 55 years to Mary A. Waldorf and beloved father of Dr. Donald W. Peterson, Jr. He passed away September 28, 2008.

Brother Frisbee received his undergraduate degree from Missouri S&T in civil engineering in 1972 and is a registered Professional Engineer in the State of Missouri. With more than 36 years in the construction industry, Dan's project experience encompasses retail/mixed use, government, hospitality, corporate, heavy civil, educational, healthcare, manufacturing, and correctional facilities. While at Missouri S&T, Brother Frisbee held many positions in the chapter including pledge class president, pledge master, a member of the initiation team, assistant house manager, rush chairman, and president. Dan was also heavily involved with various campus organizations throughout his tenure at Rolla. After graduation, Dan's involvement with the Missouri S&T campus as well as the chapter did not fade. He was a member of the Alpha Kappa House Corporation from 1974 to 1980 where he was president of the organization for his last three years. For his notable contributions to the chapter, Dan was awarded the R.V. Wolf Outstanding Alumnus Award in 1992. Even after receiving this distinguished award, Dan's involvement with Alpha Kappa only grew and was proven through his part on the construction, architect, and general contractor committee for new house construction after the old chapter house burned down. He has been a board member on the Alpha Kappa Alumni Association and currently serves the Miner Alumni Association Board on the finance and government advisory committees.

Brother Frisbee has had a very extensive and successful professional career. After graduating from Missouri S&T, Dan went to work as a Material Testing Specialist for the Missouri State Highway Department. After only a year in that position, Dan joined the Tarlton Corporation and remained there for nearly twenty years where he became a Vice President and Partner of the company. He then changed companies in 1994 by becoming involved with Fru-Con Construction as a Senior Vice President and Division Manager. Dan was only with Fru-Con for about five years before becoming the Vice President of Brinkman Construction in 2000. After one year with Brinkman, he then moved to Mosley Construction to become Executive Vice President and Chief Operating Officer of the firm. Dan then made one final change of firms to Walton Construction in 2002 where he began as Senior Vice President and Division Manager. He is currently the Chief Executive Officer and Owner of Walton Construction. He was tragically killed in a plane crash in August 1972. The scholarship is awarded each year to an outstanding 4th or 5th year student.

Dan has many other family ties to the school and to the fraternity. Dan's aunt, Bernie Rippert worked as a cook for many years in Alpha Kappa house. The Bernie Rippert award was established in her honor to recognize outstanding pledges. Bernie was beloved and served as a friend and advisor to everyone in the house.

Three of Dan's nephews also attended Rolla. Dan's niece and sister in law are currently employed at Missouri S&T and Dan's niece served as a past editor of S&T Magazine.

Dan was introduced to his wife Jackie at a pledge brother's wedding in 1972. They married in 1975 and live in Manchester Missouri. Jackie is an elementary school principal for the Parkway School District. Dan and Jackie have two children, Jenny and Steve, who are both working on their own careers. When he is not working, Dan enjoys traveling with his family and reading.

Fall 2003 Scholarship

The Fall 2003 Pledge Class made a significant impact on the long term success of Alpha Kappa during their undergraduate years. This pledge class continues to lead the Fraternity as young alumni. We are proud of the achievements of F2K3. We are grateful for not only what they contributed to AK as undergraduates but now as they lead the Fraternity with the establishment of a Pledge Class Endowed Scholarship Fund. The Fall 2003 pledge class would like to challenge other pledge classes to strive to make similar contributions to the Educational Foundation and see how they can compare with their own.

Philip Colombatto Contributes \$100,000 to Alpha Kappa Educational Foundation


Brother Phil Colombatto (AK `68) made a major contribution to the AKEF Capital Campaign with a \$100,000 donation to the Educational Foundation. The income from his contribution will support chapter officer leadership awards.

Phil was initiated into Alpha Kappa on February 24, 1968, and graduated from UMR in 1971 with a bachelor's degree in Civil Engineering. As an undergraduate, he served in various chapter leadership positions and was a stand-out shortstop on the Miner baseball team for four years. After graduation, Phil worked as an engineering systems analyst with the Los Angeles County Flood Control District before returning to Rolla for his M.S. degree. He received a master's degree in Engineering Management from UMR in 1976.

Brother Colombatto had a long and distinguished career with Anheuser-Busch Inc. He began in the Management Systems Division of Anheuser-Busch as a management research analyst. In this position he was assigned to produce a model of Anheuser-Busch's brewing process and worked closely with "Old World" brewmasters to learn the art. Phil held various positions of increasing responsibility leading to Senior Brewmas-

ter at Anheuser-Busch's St. Louis Brewery. Phil held that position until 1994, when he became Vice President of the Quality Assurance Division, reporting directly to the president, August A. Busch IV. In this position he developed and managed Anheuser-Busch's quality programs and standards for U.S. and international beer operations. Brother Colombatto retired from Anheuser-Busch in 2008.

Supporting his university as well as his fraternity, Phil served as a speaker for the chancellor's Leadership Academy in 2004–2005, and in 2006 was inducted into the Academy of Engineering Management at Missouri S&T.



Scholarships

Continuation of the Alpha Kappa Scholarship Program

Alumni who received scholarships during their tenure as undergraduates from the Alpha Kappa Scholarship Program from inception to 2001 were acknowledged in the past four issues of the Kapers. This addition of the Kapers will span the years from 2002-Spring Semester 2004.

Chapter House Upgrades

Kitchen Update — January 2009

After the tragic fire in February 1999, our faithful cook, Betty, planned meals and cooked for the Active Chapter using the borrowed facilities at the Baptist Student Union and the local Methodist Church. Sixty to seventy Brothers enjoyed Betty's friendship and service. These were tough times.

Betty was asked to participate in the kitchen design as we proceeded to replace the old lost facility. The new kitchen facility was constructed in 2000 to serve seventy to eighty men in a style of cooking most favored by Betty.

When the Chapter House was expanded in 2007, Betty was faced with meal preparation for the possibility of more than 100 at the table! Sadly, Betty decided to retire during the 2008 spring semester. With the help of Jim Murphy, we were able to contract with Chartwell Company, the food service provider for the University, to finish out the semester.

During the summer months a search was completed with the hiring of Marie Nelson on a trial basis. Marie jumped right in and began to prepare fabulous meals. The attendance at the dinner table grew from 90 or so, to more than 100 on a regular basis. Marie was preparing fewer fried foods and was interested in providing more baked and conventionally cooked foods. The Brothers are giving her high ratings.

Midway through the 2008 fall semester, Josh Heger brought to House Corporation attention that Marie was requesting changes in the kitchen equipment layout. It was preliminarily estimated that it could cost between \$15,000–\$20,000. Several alternatives were being suggested. After meeting with Marie, and considering the limitations of the space available, a layout was agreed upon that would support her style of cooking. Also, some of the eight-year-old equipment was in need of major maintenance or replacement.

Competitive bids were secured from C.A.R.E. Co., Camdenton, Mo. and Servco, St Louis for a new range with a 30" grill, four top burners and two ovens, a double convection oven unit, addition of side panels for the safety hood, rework of the fire suppression



system, relocation of the larger deep fryer, rework of the gas connections, castors for all of the equipment and installation of all the items in a new cooking line-up.

C.A.R.E. was the low bidder and offered trade-in allowances for the old, worn out, range and the smaller deep fryer. We proceeded with a \$12,500 expenditure, and the equipment changes were completed during the first week of January.

Marie is very Happy with the new set-up! The first day back of spring semester, she baked brownies for the guys in her new convection ovens. This writer has enjoyed roast beef and baked ham dinners with all the trimming and desert on several occasions.

We also appreciate Marie's management skills and enforcement of the "stay out of the kitchen unless you are on the work crew" rule. We are now better using the "food line concept", and after evening clean-up, the kitchen is locked down until the following morning. The weekend kitchen is being used for "disposal" of leftovers and breakfast dining as was originally contemplated. We think that our new practices, including purchases of miscellaneous required utensils, the new kitchen equipment and adherence to make-sense sanitation rules should improve the health and safety of the Brothers.

Thank you Marie for your good ideas, management skills and good food! You've made the team.

Back in Time: 30 years ago

The Parents' Club, in conjunction with the Little Sisters completed the drapery project for the house. Other house projects included the purchase of a new steam table and general upgrade of the kitchen area. Work was not limited to the house as Alpha Kappa also participated in several community projects. They helped restore an old building in Ber Juan Park into a Youth Center for the City of Rolla. The brothers also helped with the Alpha Phi Omega project at the Rolla Sheltered Workshop. The financial system of the house was based on a \$150 per month house bill, broken down to an \$18 social fee, \$60 room rent, \$72 for board for actives and \$57 for board for pledges (less than the cost of a dormitory). This amount enabled the Chapter to remain on sound financial footing with a 55-man house budget.

From the House Corporation President

As we all know, for decades Bob Wolf was the House Corporation (HC), the Alumni Association (AA) and to the extent that any contributions were made he was the Educational Foundation (EF) plus the only long term contact with the Active Chapter (AC). After his death, the decision was made to formally establish these four entities as separate ones with a common mission and vision.

Because all Alpha Kappa alumni are members of the HC, I want to let you know how the HC is structured and of its leadership and successes.

The HC was recognized by the international Pi Kappa Alpha Fraternity with the Best Chapter House Improvement Award this last August for the addition of the Al Powell Wing. The Operations Manual which was developed under the leadership of the HC is the cornerstone for Alpha Kappa receiving the award as the Best Managed Chapter in PiKA two of the last four years.

None of these accomplishments could be obtained without the dedication of Alpha Kappa alumni who have been very generous with their time and financial contributions. There are many talented brothers on the HC BOD and each of these brothers has dedicated himself to exceeding any expectations.

Bob Kallemeier who graduated in 1962 is the Vice President and previously has served as President. He was the person with direct responsibility for working with the architects and construction companies for both the 2001 house and the Al Powell Wing two years ago. He currently coordinates all major improvements with the contractors.

Secretary/treasurer is Don Myers. Don graduated in 1961 and has been on the faculty at MST for decades. Don handles all of the financial aspects of the HC including obtaining bank loans for the addition to the house, collection of the rent from the AC and payment of bills for maintenance and repairs. He also is the eyes and ears of the HC as all maintenance reports are filed with him by the House Manager. Don then hires local craftsmen to perform the repairs. (The AC no longer does any major repair to ensure that the quality of the house is excellent at all times thus protecting our investment of over \$6 million in the Chapter House.) Each summer, Don also is responsible for overseeing about \$50,000 in general maintenance to fulfill the HC's policy to have a "like new" chapter house each fall.

Dave Zimmerman, my predecessor as HC president and 1989 graduate, is responsible for the retreats held at the end of each semester and attended by the AC'S outgoing and incoming officers as well as officers of the HC, AA and EF. These retreats which have been reported in other issues of the Kapers are extremely important in continually to improve the overall quality of the four entities. Dave not only

arranges for the lodging and meals but facilitates the retreats. His skill in leading the retreats allows all participants to express their ideas of how to better Alpha Kappa and to develop actions plans based upon the experience of all attendees.

Trace Shaughnessy joined the HC BOD in 2008. Trace, a 1986 graduate, is the president of The Gilded Age, a development company that has among other projects redeveloped the old St. Louis City

Hospital complex into a condo complex. The HC has recognized that given the complexity of the physical structure of the house we need to be sure that each of the major officers has an understudy who can smoothly step in to the officer role. Trace is that person for Bob Kallemeier and Don Myers.

The newest member of the HC BOD, Dan Frisbee, joined the BOD this March. Dan, a 1972 graduate, is President of Walton Construction and a former president of the HC. More about Dan is in the HC profile elsewhere in this issue of Kapers. Dan is the understudy for me.

Chris Ramsay, the Alumnus Advisor, is also a key member of the HC by virtue of his role. He works closely with the AC and is greatly respected by the AC as well as the HC. He
