Thanks to the effort of our Director of Recruitment, Brian Van Booven (AK '10) and his rush committee, our chapter is in progress of rushing another large class full of the "Most Best Men" on campus. This is in part due to the large success our chapter has had in generating names with the help of alumni and parents.

Pikes have managed to be recognized as leaders in every important organization on campus. Andrew Busby (AK '09) is representing AK in IFC as Vice President-Internal. Ryan Brunkhorst (AK '07) is the Treasurer of Student Council, and Jordan Wengler (AK '10) is on the Board of Directors of Student Union Board. John Van Gels (AK '08) is serving on the Greek Standards Advancement Board, which grades and improves the Greek Plan for Success. His involvement has been vital to our success as a "Level III Chapter." Furthermore, we have many athletes that received All-Conference, All-Region, Academic All-American in Men's Varsity Soccer, including Pat McNamee (AK '08) who received Defensive MVP for the GLVC region.

Our chapter continues to be the envy of campus. The Greek Awards Banquet was truly Garnet and Gold, as Pikes took home the Order of Omega Award of Excellence, given to the best fraternity on campus. I also received the Don Myers Fraternity Man of the Year award. This is the 2nd year the award was given out, and the 2nd year a Pike has received it. Furthermore, the chapter had two new initiatives for the semester. The first was to reevaluate the strategic plan, which will allow it to be as successful for the next five years as it was for last five years. This plan gets re-evaluated every five years or so and incorporates all of the alumni entities as well as the Active Chapter. The other new initiative was the transition over to OmegaFi, a financial collection agency endorsed by Pi Kappa Alpha International.

The chapter also initiated twenty eight young men into the chapter this fall, the largest initiation any of the active members can remember. Furthermore, the chapter had two special initiations this semester. The first was John Francis Carney III, who has served Missouri S&T as Chancellor for the last five years. The second is David Lewis Ryan, the father of Daniel Lewis Ryan (AK '06). Daniel currently serves as the Director of Chapter Services for the International Fraternity. These men are the 29th and 30th special initiates of Alpha Kappa.

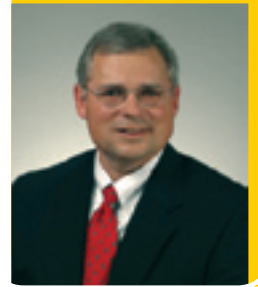
## The Bauer Bar

## Chancellor Carney Initiated

Alpha Kappa has a history of special initiations, but on February 25th, special gained a new meaning. Dr. John F. Carney III has served Missouri S&T for nearly six years as the Chancellor, leading the school to many new achievements. Upon the announcement of his retirement, he expressed interest in the intrinsic bond that fraternity members share and soon was initiated into the bonds of phi phi kappa alpha. Chancellor Carney has brought many positive changes to the school. One of Carney's most visible changes was the decision to change the name of the campus from the University of Missouri-Rolla (UMR) to Missouri University of Science and Technology (Missouri S&T) to better position the campus as a nationally recognized technological research university. The name change took effect Jan. 1, 2008, following months of discussion and evaluation. Since the name change, the campus has experienced increases in out-of-state and international undergraduate applications as well as strong alumni support. During his tenure he oversaw the addition and renovation of Toomey hall, the mechanical and aerospace engineering building. He has presided over the creation and construction of Innovation Park, which lies now where the old golf course was. Being a man of athleticism, he understood the needs of all varsity athletes and helped with the construction of the Miner Dome, a large indoor practice facility for many varsity sports. Another development Carney presided over is the restructuring of the academic organizations on campus. It used to be very separated with different schools and colleges. Now a more collaborative structure is in place, creating much ease for interdisciplinary activities. Prior to becoming chancellor of Missouri S&T, Carney served as provost and vice

president for academic affairs for eight years at Worcester Polytechnic Institute in Worcester, Mass. He began his academic career as a member of the civil engineering faculty at the University of Connecticut, serving there for 15 years before joining Auburn University in Auburn, Ala., as professor and head of the civil engineering department. In 1983, he moved to Vanderbilt University in Nashville, Tenn., where he served for the next 13 years as professor of civil engineering, associate dean for graduate affairs, and associate dean for research and graduate affairs. Dr. Carney has served Missouri S&T very well and Alpha Kappa is honored to have such a prestigious and inspirational brother. We wish him well on his retirement and look forward to the times ahead with our new brother.

## Dustin Hale Survives Accident

Before the International Convention this last summer, Dustin was just a regular college Pike. Then one night his world was turned upside down, and his life has been changed for the better. After returning home from the convention, Dustin was exhausted but still made his way in to work the next day. "I checked my temperature before work and I was running a fever. I had chills all day. I probably should have called in but that's life," says Dustin. After work he climbed into his car and started driving the long highway trek home. "The next thing I remember is glimpses of the hospital. They were like a dream." Dustin had lost consciousness at the wheel and drove into a ditch causing serious damage to himself and his vehicle. The next week, Dustin's family and friends spent a lot of time with him in the hospital. Brian Phagan, a pledge brother of Dustin, stayed for two straight days. Dustin's younger brother Corey, also a Pike, spent every free moment available just staying at his brother's side. After Dustin's initial recovery, he was quickly back in the hospital for more surgeries due to a persistent bacterial infection. He says he is lucky he didn't succumb to

any brain damage. The infection was finally subdued, but too late for him to start school in the fall. Dustin was greatly missed during the fall semester but surprised everyone by attending all the community service events that semester. Community service has always been an ambition for Dustin and he claims that this accident has further taught him the responsibility of helping other. "Life's short. Why not help somebody else while you're in it? I feel now that I have been enlightened. Why be a jerk when you can make friends? Why miss out on any opportunity in life when life may be unexpectedly snatched away? My life has been changed for the better." Dustin is now back at Missouri S&T for the spring semester and is serving the house as the community service chair. Many find inspiration in Dustin's story and everyone is glad to have him back.

# Intramurals

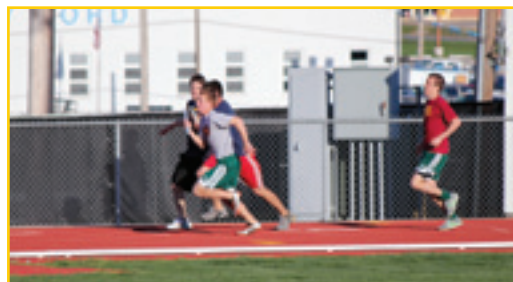

## Bob Brockhaus receives the 2010 Robert V. Wolf Loyalty Award

Each year the Alpha Kappa Alumni Association selects an AK alumnus to receive the Robert V. Wolf Loyalty Award. This year's recipient was Dr. Bob Brockhaus, MSM 1962, and current House Corporation president. Selection is based upon the individual's service to the chapter, to the national fraternity and to the university. Previous recipients since the award was reestablished in 2005 are Dick Bauer, Don Myers, Bob Kallemeier, Rollie Johnson and Al Wentz.

### Undergraduate and Pi Kappa Alpha involvement

Bob served as ThC and Steward while at MSM. He held several offices in Alpha Phi Omega Fraternity including serving as president. A member of the Miner and Rollamo staffs, he was initiated into Theta Tau Fraternity. His honors include being on the Dean's Honor Role and being selected for Who's Who in American Colleges and Universities. His senior year, AK was the recipient of the Smythe Award, which was only given to one chapter each year at that time.

He has served as the District President for the PiKA chapters in Kansas and later for those in Missouri. He was the alumni advisor for the Beta Phi chapter at Purdue University when it built its current chapter house. Later, he was the first faculty advisor for the Iota Nu chapter at Saint Louis University when it was chartered in 1990. He served for over a decade during which they received several Smythe awards and the trophy for the best chapter GPA. Since 2002, he has been a member of the AK House Corporation. He has served as president for the last several years during which time the chapter has consistently received the Smythe Award and has been widely recognized as the best managed chapter in PiKA. He and his wife, Dr. Joyce Brockhaus, are members of the Order of the Golden Shillelagh.

### Educational and Professional activities

Bob has a mechanical engineering degree from MSM, an MBA from Purdue University and a doctorate degree in business from Washington University. Upon graduation from MSM, he worked for Ralston Purina for seven years prior to starting his own businesses including restaurants near UMSL and UMR. The restaurant in Rolla was located where Wolf Hall

stands today. Older alumni may recall the restaurant as the Wee Chef. When the House Corporation purchased the site in 1970, they leased it to Bob and he operated a restaurant known as Another Place. In 1972, he sold the restaurants to join the faculty at Saint Louis University. Bob is President of Progressive Management Enterprises, Ltd., a real estate management firm, that he founded in 1969. He also is the Managing Director of the Brockhaus Group, LLC which provides consulting services to large family controlled businesses in the United States, Europe and Africa. The initial Coleman Foundation Entrepreneurship Chair holder and Director of the Jefferson Smurfit Center for Entrepreneurial Studies at Saint Louis University, he served in these roles for over 30 years.

Under his leadership, SLU developed an entrepreneurship program recognized for its excellence around the world. He remained at SLU until his departure in 2004 to concentrate on his consulting business. He previously has been a Fulbright Fellow at the University of Waikato in New Zealand, the Schoen Professor of Private Enterprise and Entrepreneurship at Baylor University, the Distinguished Visiting Professor of Entrepreneurship

at Southern Cross University in Australia, the McAnich Chair of Entrepreneurship at Kansas State University and the Extraordinary Professor of Entrepreneurship at Potchestroom University in South Africa.

In 2005, he received the national Hughes award for his advocacy of

entrepreneurship from the United States Association for Small Business and Entrepreneurship and was honored along with his wife by the international Family Firm Institute with its award for their global work with family businesses. In 2003, he was selected by the United States Small Business Administration as its first national Entrepreneurship Research Advocate.

He is the past State Director of the Missouri Small Business Development Centers, past national chairperson of the Academy of Management's Entrepreneurship Division, past national president of the Small Business Institute Directors' Association, past international president of the International Council for Small Business which he also served as Executive Director for 20 years and received an Honorary Life Membership. He was an elected delegate to the 1986 and 1995 White House Conferences on Small Business. He also is a Fellow of five different academic entrepreneurship organizations.

He currently serves on various universities, civic and religious boards in Europe, South Africa as well as in the United States. Bob is listed in Who's

Who in the World, Who's Who in America, Who's Who in Finance and Industry and International Who's Who in Education. He has been an invited speaker in Australia, Brazil, Canada, China, Croatia, England, Egypt, Finland, Germany, Ireland, Japan, Korea, Lebanon, Mexico, New Zealand, Singapore, South Africa, Switzerland, as well as throughout the United States.

### **Civic and community involvement**

A four term alderman for the City of Sunset Hills, Missouri, Bob has been president of his church council, former troop committee chairperson and currently is vice-chair of the executive committee of the local Boy Scout district. He currently is president of the Homeowners Association in the Florida Keys where Joyce and he have a home. In recognition of his service he has been the Father of the Year for his son's high school, one of the first ten Distinguished Alumni of Lindbergh High School, and the Citizen of the Year for Crestwood and Sunset Hills. Our sincere congratulations to Brother Brockhaus for this service to Pi Kappa Alpha and his career accomplishments.

# Founders' Day

## Highlights of Brother Brockhaus's Founders' Day Talk

Each year the recipient of the Robert V. Wolf Loyalty Award is the speaker at the Founders' Day program. This year's recipient was Bob Brockhaus, president of the House Corporation. Approximately 200 alumni, parents and undergraduates were present as letters from classmates of Bob's were shared by Brother Kallemeier who was a classmate as well as the current vice-president of the House Corporation. The letters gently roasted Bob. More information about Bob is elsewhere in this issue of the Kapers.

In his talk, Bob shared that it was 106 years ago that the Alpha Kappa Chapter was founded and 53 years ago that he pledged PiKA. He never met any of the founders who he considered extremely old when he was eighteen as he suspected the current pledges felt about him. He pointed out that the values that were true 106 years ago were still true 53 years ago and remain true today.

Bob pointed out that while the computers of today have replaced the slide rules that Bob and his contemporaries wore attached to their belts, the value of the accuracy of the calculations remain the same. The same is true with "traditions" within the chapter. When Bob was a pledge, pledges were paddled for failing to correctly

perform duties around the chapter house. During Bob's senior year, paddling was eliminated and a demerit system replaced it which required the pledges to do extra tasks to work off demerits. In both "traditions" Bob pointed out that the real purpose was to ensure that the house was kept clean and operated effectively.

He illustrated other examples of "traditions" that were replaced over the years by new "traditions" which were later themselves replaced. Bob's point was that changing "traditions" or practices can be done without changing the importance of the value which supported the "tradition". He urged the Brothers to review any practices that had any negative aspects and look for new more positive practices to replace them without changing the underlying values. It is this philosophy that has allowed Alpha Kappa to remain among the very best chapters in the Pi Kappa Alpha Fraternity and the best fraternity at MST. active chapter and pledges gathered across the street in the intramural fields to play football for most of the afternoon.

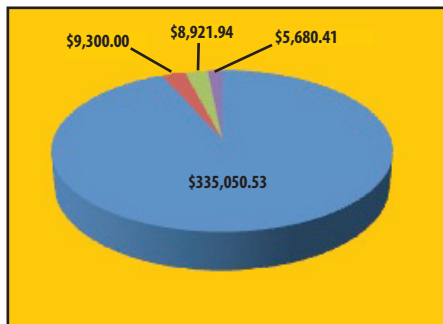

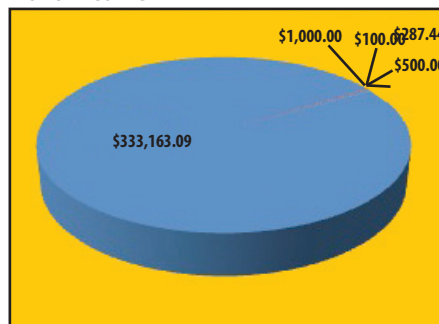

2010 Income



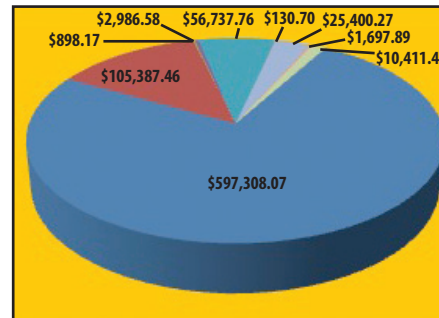

# House Corporation

## Member Profiles

In the last several issues of the Kapers, profiles of the individual members of the House Corporation Board of Directors have been published. In this issue, we summarize the background of the entire board. The professional experience and commitment of the BOD is critical to the maintenance of our chapter house with a value of over six million dollars and the BOD's policy of bringing the house back to a "like new" condition prior to the start of school each fall.

### President — Bob Brockhaus, 1962

Bob is president of Progressive Management Enterprises, Ltd. which owns holiday rental property and is the Managing Director of the Brockhaus Group which provides consulting services to families that own large businesses in the United States, Europe and Africa. Bob's doctorate is in business administration and from 1973 until 2004, he held the Coleman Foundation Chair of Entrepreneurship at Saint Louis University and directed its internationally recognized center for entrepreneurship. More about Bob is elsewhere in this issue.

### Vice - President — Bob Kallemeier, 1962

Bob is a retired Anheuser Busch executive whose responsibilities included the overseeing the construction of A-B breweries throughout the United States. Bob has also been very involved with the construction of buildings at the various camp facilities of the Greater St. Louis Council of the Boy Scouts of America. Bob also was the representative of the House Corporation during the design and construction of the new chapter house constructed after the fire and of the Al Powell Wing addition. Bob's detailed knowledge of the chapter house facilities is of immense value to the maintenance of the house. Bob is a past president of the House Corporation and a recipient of the Robert V. Wolf Loyalty Award.

### Secretary — Trace Shaughnessy, 1986

Trace is currently a project manager with CRB Engineers in St. Louis. He formerly owned the development firm that renovated the old St. Louis City Hospital complex into condominiums.. His responsibilities for the House Corporation go far beyond the role of secretary as he is the point man for all repairs. Prior to the fire, most repairs were made by the active chapter. Following the construction of the new chapter house, the decision was made to have all major repairs made by professional tradesmen. Trace works with the House Manager and the tradesmen to ensure that all repairs are made promptly and properly. Each summer, Trace oversees the program to maintain and improve upon the quality of the physical facility and bring the chapter house to a "like new" condition. Trace is a former president of the House Corporation.

### Treasurer — Jim Murphy, Honorary Initiate

Jim is the Assistant Vice-Chancellor for Students at MST. In this role, he is responsible for all student services including housing, advising and discipline. Jim also is the faculty advisor to the chapter. The combination of these two roles provides the House Corporation with insight into the housing alternatives on campus including not only the university owned housing but the housing plans of the other fraternities. He also is able to provide guidance to the chapter and House Corporation in regard to the strategic plans of the university. As with Trace, Jim's service to the House Corporation goes far beyond his role as treasurer.

### Board of Director Member — Dave Zimmerman, 1989

Dave, a former SMC, is president of RJJ, a manufacturing representation company for the heating and air conditioning industry, which was founded by Brother Rollie Johnson. That Dave has been very involved with the HVAC systems at the chapter house is not surprising. However, Dave's primary role is to serve as the facilitator of the retreats held at the end of each semester. When Dave was House Corporation president, he established the practice of holding these retreats to which all outgoing and incoming chapter officers spend a weekend with the boards of the House Corporation, of the Educational Foundation and of the Alumni Association as well as other interested alumni. These retreats have provided a long range strategic plan for all four entities, actions plans to fulfill the strategic plan, transfer of chapter leadership roles as well as opportunity to address current issues confronting Alpha Kappa.



# House Corporation

## Board of Director Member — Dan Frisbee, 1972

Dan is the former CEO of a 500 million dollar construction company with a wealth of knowledge about construction as well as management at the executive level of a large company. Dan has served as the SMC and is a past president of the House Corporation and his current role is to provide support in any area in need of assistance. He also is very involved with the Miner Alumni Association.

**In addition to these elected House Corporation members, there are three other Brothers who serve on the board because of their other roles.**

## Educational Foundation — Keith Wedge, 1970

Keith is president of the Educational Foundation as well as secretary of the Miner Alumni Association and chairman of the Mines and Metallurgy Academy of the MST. A retired Brigadier General with a doctorate from MST, Keith served as SMC. He is currently is program manager for Contingency Engineering at Advancia Corporation with offices in St. Robert, Missouri and in Huntsville, Alabama. While his home is Rolla, he is frequently travels to support training for military units in the United States and overseas. Keith and the Educational Foundation administer all of the scholarships for Alpha Kappa members. Awards are based on several factors including grades, athletics, leadership positions as well as others. Keith works closely with Chris and Jim to be sure that officer awards recognize efforts to properly maintain the house.
